JUVENILE 4 PROBATION LOBBY

- When entering the courthouse, you would walk straight down the hallway until you pass the sitting area (cafeteria) where you would then turn left.

COVE PREP

I took a trip to Cove PREP which is a secure facility for juvenile sex offenders. It is in Torrance, PA 15779 on the same grounds as Torrance State Hospital. I met with a juvenile who has been in this facility for about a year and a half.

-bottom right picture is the facility housing this juvenile which is for sex offenders.




SCHOOL PROBATION



MOOD CHARTS

These are three of the charts that the PO used during our two visits. The top left is a goal worksheet that makes the juvenile explain their long-term goal. This sheet can be redone and updated overtime. The top right is a cost benefit analysis which breaks down two of the juveniles' behaviors and shows how those behaviors can be beneficial or costly in short and long-term situations. The bottom right picture is a behavior chain where the juvenile will give the PO a recent situation they were in and the events that happened after the event.
